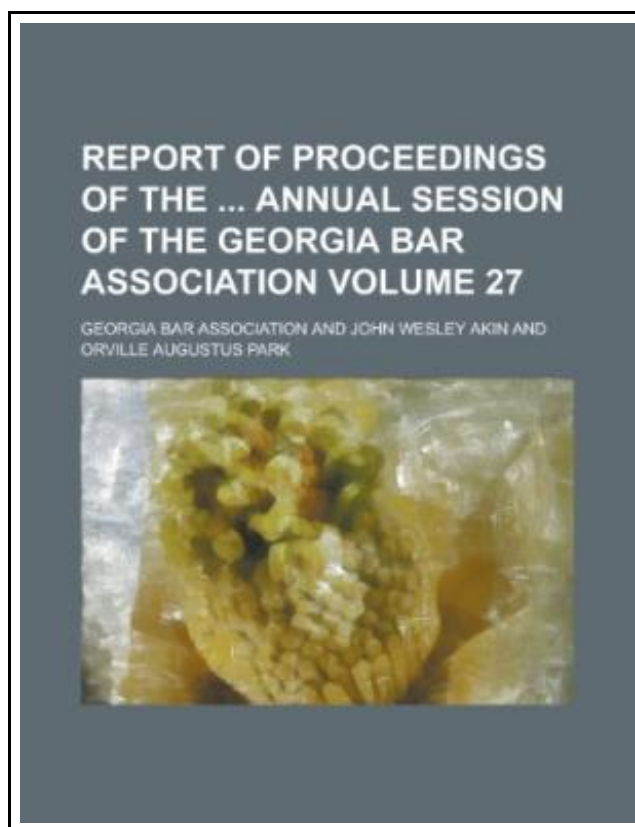

Excerpt: . . . to play an important part in our judicial system. To my mind, the people of the State are more interested in this court. than they are in the City or County Courts. It is really the court for collection of small debts and for the adjustment of small differences that will arise. The trouble is that these courts are not now established on the right basis. I am not here to criticise our legislators or our courts. The legislators have been too busy worrying about railroad and kindred legislation, and have not given the matter of the reforms in our Justices Courts the attention that these courts deserve. These courts have grown in importance, and there has been no legislation to meet the needs of this growing court. The courts have dealt gently with cases coming from Justices Courts, evidently feeling it their duty to try to keep them in existence until they could be properly nourished by legislative enactment. The reforms I would suggest are these: (1) Put all Justices of the Peace on a salary basis. (2) Make the Justices of the Peace at the county site trial justices only. The Justices of the Peace in rural districts shall be peace officers, rather than judges. (3) Prescribe qualifications for holding the office of justice of the peace. Require that the justice of the peace at the county site shall be a lawyer. Require that the justice of the peace in the rural...
